One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, wide, low half round, tapered band of 4.44mm width (at base) x 1.25mm depth, with open back settings, and a curved underrail,

Feature curved rectangle top plate, housing thirty round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the underrail, and in between the tapering shoulders,

of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Thirty claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed). Dimensions (average) = 2.08mm(Dia) x 1.27mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 8.04 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 7.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
