### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.06mm width (at base) x 0.68mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one oval natural sapphire, claw set. Either side of the central setting is one four claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured on top of a dished decorative plate. The plate is attached to the 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped '750 \*1386 AR' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

One claw set oval shaped natural sapphire, "blue".

Dimensions = 5.42mm(L) x 4.21mm(W) x 2.39mm(D-estimated)

Total Weight = 0.46ct (estimated - see NOTE below)

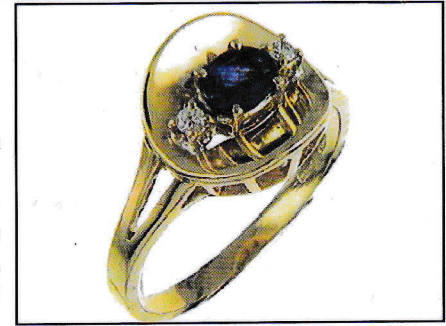
Two claw set round brilliant cut diamonds, clarity is "P2", colour is "G to H" (mixed).

Dimensions (average) = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.47 grams Total Gemstone Weight = 0.52ct Total Metal Weight = 4.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
