Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.06mm width (at base) x 1.18mm depth, with open back settings, and a curved underrail.

Feature round white gold top plate, within a four claw setting, housing nine round brilliant cut diamonds, largest to the centre, and claw set. The top plate is secured between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished yellow gold band. Each of the shoulders houses one row of four round brilliant cut diamonds, channel set. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '375 JP88' - acid tested 9 carat gold.

Ring size: Q.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 2.85mm(Dia) x 1.74mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Sixteen claw and channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 1.57mm(Dia) x 0.96mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.65mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.70 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 2.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
